

# TERMS of PARTICIPATION

## 1. Important Advice

- The use of the adventure park requires **concentration** and is associated with **risks** that can lead to serious injuries. You use the park at your own risk. To ensure that you maintain the correct level of concentration, the park should be used for a **maximum of three hours**.
- Every user of the adventure park must take part in a **safety course** and complete the practise course correctly. The adventure park must be used in accordance with safety rules and the demonstration in the practice park.
- **The various courses are followed without supervision.** Users of the adventure park are responsible for their own safety and must obey the rules according to the safety demonstration. When those rules are not followed users may be asked to leave the park. The owner of the park is exempt from responsibility.

## 2. Eligibility requirements

- Maximum weight is **110kg**. The park is open to everyone except those who are physically or mentally incapable of completing the course and could bring themselves and/or others into danger. People under the influence of **drugs or alcohol** are forbidden from using the adventure park.
- Children **under the age of 14** must be accompanied by a legal guardian in all areas, apart from the Bambi course. The legal guardian must ensure that they are **in close quarters to the child under 14**. They must also observe that the requirements of the safety course are followed at all times by themselves and the child under their guardianship.
- The **black course** can only be used by those **over the age of 16**.

## 3. Special safety regulation according to demonstration and practice course

- The **safety key** must be **inserted** into the security cable (safety line) at the beginning of every course. In addition, the **safety carabiner** must always be **attached** at the red marking. **Attention!** Except at the climbing walls and the start of the black courses: there, the safety carabiner must be clipped onto the **self retracting lifeline** (pictures on site are referring to that as well).
- The rope slide (**flying fox**): The **pulley** must be clipped to the rope marked in **green**. Before starting, the **flying fox must be clear** of people to avoid a collision.
- Each station can only be used by **one person at a time**. The platforms can be used by a **maximum of three people**.
- **Long open hair** must be tied back or secured in such a way that it cannot be caught; for example in the rope slide. **Naval piercings** must be covered with a plaster or removed to prevent it catching on equipment.
- When using the park, **items** like mobile phones, cameras, rucksacks, drinking bottles etc. **may not be used or attached** to the user as they could fall on others or cause the user to get stuck.
- The **equipment** (helmet, climbing harness, straps with safety key and safety carabiner, pulley) must be used in according to the safety and practise course and **mustn't be taken off** during the use of the adventure park.

## 4. Further conditions

- The park reserves the right to remove people from the park that do not abide by the rules stated or close the park for safety reasons. The park also reserves the right not to reimburse the affected users in these cases.
- The park is not responsible for injuries or damage caused by other users of the park.
- The park is not responsible for items that are stolen within the adventure park including the unprotected storeroom, damaged clothing or loss / damage to any other items. For other property damage, the organizer of the park is only liable by gross negligence. The park is not responsible in the case of force majeure.
- The park reserves the right to use any photographs or movies taken by the park owners / or workers including material where people might be recognizable for any advertising or for web pages as and if needed.
